## **COVID-19 INFORMATION**

March 20, 2022: As noted previously, masks in healthcare settings are still required under OAR 333-019-1011. The Oregon Health Authority has <u>published an updated FAQ related to the masking requirements.</u> Additional information from OHA about COVID-19 resources and requirements can be found on their COVID-19 Healthcare Partner Resources Page.

**February 7, 2022:** State Health Officials have announced that Oregon will remove general mask requirements for indoor public places no later than March 31. *This will not impact the use of masks in healthcare settings, as OAR 333-019-1011 remains in effect and is separate from the general indoor mask mandate.* Click here to watch the announcement from the State Health Officer.

January 31, 2022: OHA has adopted OAR 333-019-1011, requiring masks to be used in healthcare settings until June 30, 2022.

**August 26, 2021:** OHA has published additional information, including forms, related to the newly updated <u>Vaccine Requirement Rule</u> on the *OHA's COVID-19 Website for Healthcare Partners*.

August 25, 2021: The Oregon Health Authority has published revised temporary rules requiring all health care workers to be vaccinated per direction from the Governor. | Health 28-2021.pdf

August 25, 2021: The Oregon Health Authority has published temporary rules relating to vaccination requirements to control COVID-19 for Schools and School-based Programs. | PH 39-2021.pdf

**August 25, 2021:** Due to the state's current hospital capacity crisis. nursing facilities may temporarily utilize the services of physical therapists and other healthcare workers to account for up to 25% of the required minimum staff required at nursing facilities, effective immediately.

August 23, 2021: FDA Approves Pfizer vaccine for individuals 16 and older.

August 20, 2021: The Oregon Health Authority has passed temporary rules requiring masks in healthcare settings.

**August 19, 2021:** Governor Brown directed the Oregon Health Authority to require all health care workers to be fully vaccinated by October 18 or six weeks after full FDA approval, whichever is later.

**July 1, 2021**: Governor Brown has issued Executive Order 21-15, which rescinds statewide mandatory COVID-19 restrictions and addresses ongoing vaccination and recovery.
