Tsab ntawv no tsuas yog ua ntaub  
ntawv rau koj xwb. Koj tsis tag yuav  
tsum tau nqa nrog koj mus rau ntawm  
qhov chaw koj teem caij mus kuaj mob.

Peb tsuas yog xa tsab ntawv tshiab tuaj  
rau koj xwb yog tias koj tau hloov qhov  
kev duav roos, los sis yog tias koj thov  
ib qho dab tsi ntxiv.

Zoo siab tos txais rau Txoj Phiaj Xwm Saib Xyuas Kev Noj Qab Haus Huv (OHP). **Ntawm no yog  
koj tsab ntawv qhia txog kev duav roos tshiab.**

Tsab ntawv no muaj cov ntaub ntawv hais txog cov npe kev duav roos rau koj tsev neeg. Tsab

no yuav tsis tseem ceeb tshaj tsab ntawv ceeb toom uas koj tus neeg ua hauj lwm xa rau koj.

Peb yuav xa ib tsab ntawv tshiab rau koj thiab ib daim npav ID Kho Mob rau koj thaum koj thov ib  
qho los sis yog muaj kev hloov cov ntaub ntawv nyob rau tsab ntawv no los sis nyob rau koj daim

Qhov no yog phab 2 ntawm koj tsab ntawv. Nws qhia koj txog koj lub CCO thiab lwm yam kev saib xyuas uas OHA paub zoo txog.
