**Re: Interim Actuarial Valuation as of December 31, 2002
Individual Employer Results**

Dear Members of the Board:

We have completed the Interim Actuarial Valuation as of December 31, 2002 for all participating employers in the Oregon PERS. In general, the actuarial valuations have been performed as of December 31st of odd-numbered years. The Retirement Board authorized a special valuation as of December 31, 2002, to monitor the experience during the interim between the 2001 and 2003 valuations.

Our understanding is that Retirement Board will not be establishing revised employer contribution rates based on this information. Therefore, the contribution rates currently in effect will continue until the results of the December 31, 2003 valuation are completed and acted upon by the Retirement Board. This action, in the latter months of 2004, will establish new rates for employers no earlier than July 1, 2005.

This report does not require any action by the Retirement Board at this time. In the near future, we will complete a final document summarizing all of our findings.

This report summarizes certain information that will be distributed individually to each participating employer. This will not be a complete valuation, but it is designed to provide certain information to employers that may be of interest. It is important to note the following:

1. No actuarial assumptions or methods were revised from the 2001 Actuarial Valuation. See the attached Appendix for a summary of the key assumptions.
2. No Governmental Accounting Standards Board (GASB) disclosures will be produced as of December 31, 2002.
3. The employer contribution rates shown in this report were calculated as of December 31, 2001 and December 31, 2002 and do not reflect the actuarial adjustment of the 2001 rates to the July 1, 2003 effective date. Because these rates do not reflect this "lag" adjustment, the purpose of showing the employer contribution rates is to indicate the impact of the 2002 experience on future rate orders.



4. The employer contribution rates that will be adopted as of July 1, 2005, will include the experience for calendar year 2003. Although we might expect a gain from the 2003 investment returns, there are still significant unrecognized investment losses from prior years that will likely more than offset the potential 2003 investment gains. In addition, we will not know the impact of the demographic experience until we collect the census data after the end of 2003.
5. Because this is an interim valuation, and employer rates are not being developed, we have accepted the 2002 census data with the recognition that there are some problems. We believe the data problems are not material for the actuarial findings of the System as a whole, however, the actuarial results for some individual employers may be materially impacted by these data problems. The issues that were readily identified include missing payroll or member accounts.

The results of the 2000 Interim Actuarial Valuation, the 2001 Actuarial Valuation, and the 2002 Interim Valuation are summarized below and on the following page.

The primary reason for the 2002 actuarial loss is the recent poor investment returns. We calculated a loss due to investment experience of \$7.0 billion and a slight actuarial gain from all other experience of \$0.3 billion. The amortization of the net actuarial loss over the next 25 years would result in an increase to the average employer contribution rate of 5.71% of payroll.

More details of the actuarial findings are contained on the next page and will be more fully described in the final valuation report.

The findings have been determined according to actuarial assumptions and methods that were chosen on the basis of recent experience of the System and of current expectations concerning future economic conditions. In our opinion, the assumptions used in the actuarial valuation are appropriate for purposes of the valuation, are internally consistent, and reflect reasonable expectations. The assumptions represent our best estimate of future conditions affecting the System. Nevertheless, the emerging costs of the System will vary from those presented in this report to the extent that actual experience differs from that projected by the assumptions.

This report was prepared in accordance with generally recognized and accepted actuarial principles and practices which are consistent with the applicable Standards of Practice adopted by the Actuarial Standards Board of the American Academy of Actuaries.

APPENDIX

KEY METHODS AND ACTUARIAL ASSUMPTIONS

The following is a brief summary of the methods and key actuarial assumptions used in the 2001 and 2002 Actuarial Valuations.

METHODS

Actuarial Cost Method	Entry Age Cost Method Level percentage of future payroll Amortization period to December 31, 2027
Asset Valuation Method	The asset smoothing method is effective for the investment experience of 2000. Annual investment gains and losses are recognized over a period of four years, and the Actuarial Value of Assets is limited to the corridor between 90% and 110% of Fair Market Value.

ECONOMIC ASSUMPTIONS

Consumer Price Inflation	3.50%
Health Cost Inflation	Graded from 8.50% in 2004 to 5.00% in 2011
General Wage Inflation	4.25%
Investment Return	8.00%
Tier One Interest Credits	No earnings were assumed to be credited to Tier One regular accounts for five years beginning with 2003 for the purposes of refunds and retirement calculations with effective dates on or after April 1, 2004. After 2007, Tier One interest credits were assumed to be 8.00% per year.

DEMOGRAPHIC ASSUMPTIONS

All demographic assumptions were adopted for use in the 2001 Actuarial Valuation and the 2002 Interim Actuarial Valuation based on the experience of the System as reported in the 2001 Experience Study.

The one exception to the assumptions adopted in the 2001 Experience Study is that service retirements from active status were assumed to be 30% higher for 2002 and 50% higher for 2003. The regular service retirement rates were applied for 2004 and beyond.

- ◆ Change (Percent): The change in the employer contribution rate as of the valuation date is simply the difference between the previous two columns.
- ◆ Change (Dollars): The difference in dollars is equal to the 2002 rate multiplied by the 2002 payroll, less the 2001 rate multiplied by the 2001 payroll.

- ◆ Employer Number

- ◆ Supplemental Deposits: Employer deposits made in 2002 and 2003, and the total, are shown for those situations in which a Side Fund has been established.
- ◆ Amortization of 2002 Side Funds: A portion of the 2002 deposits has been used to offset a reduction in employer contributions in 2002.
- ◆ Value of Side Funds at December 31, 2002: The Supplemental Deposits shown are adjusted for actual interest credited and the amortization of contribution offsets for 2002.
- ◆ Original Rate Reductions: This is the reduction in employer contribution rates established at the first of the month after the deposit.
- ◆ 12/31/02 Rate Reductions: This represents an interim estimate of the revised rate reduction based on actual interest credits in 2002 and actual 2002 salaries. Note this item is for illustration only, and rate adjustments will not be made until the results of the 2003 valuation are known.
